up to 7 days in advance.

- All recipients are required to submit a
Provider Certification Form.

In order to be eligible for Medicaid coverage of your
transportation:

- You **MUST** be covered by Medicaid and have
an *active* Medical Assistance (MA) number.
 - *Specified Low Income Medicare
Beneficiary (SLMB) and Qualified
Medicare Beneficiary (QMB) are NOT
ELIGIBLE for the program. Pending MA
cannot schedule rides until their
coverage is active in the system.*
- You must not have any other way to get to
the appointment you are requesting
transportation for. This transportation can
only be used as a LAST RESORT.
- You must reside in Montgomery County; have
a certified medical necessity that prevents
him/her from utilizing public transportation;
and/or resides within a rural city within the
County and has absolutely no means of
getting to medical appointments.

It is only for services that are **MEDICALLY NECESSARY**
and are **COVERED BY MEDICAL ASSISTANCE**.

It is a scheduled, shared ride program for
transportation to and/or from medical
appointments during normal business hours. (You
will often times share a ride with other clients)

- **Only Medicare Part C (Medicare Advantage)
may include non-emergency
transportation.**
 - Check your specific Medicare
Advantage plan to see if it offers
non-emergency transport.
- Medicare Part A and Medicare Part B **do not**
cover non-emergency transportation
- With a written certification from the doctor,
Medicare Part B patients may be eligible to
receive transportation from home and back.
- **THERE IS NO GUARANTEE YOU WILL
RECEIVE TRANSPORTATION COVERAGE.**
- **If you do not book your transportation
through your Medicare Advantage plan,
you cannot be reimbursed for this cost!**

pocket
- Zone 1 20 mile radius of Baltimore
 - 22.95 + \$2.10 per mile
- Zone 2 20-30 mile radius from Baltimore
 - 26.95 + \$2.10 per mile
- Zone 3 30-45 mile radius from Baltimore
 - \$34.45 + \$2.10 per mile
- Zone 4 45-70 mile radius from Baltimore
 - \$46.95 + \$2.10 per mile
